The Universities / Deemed Universities / Private Universities conducting courses in Allied and Healthcare Professions are informed to constitute a Dedicated Board of studies for Allied and Healthcare education to ensure appropriate academic governance, effective curriculum implementation and alignment with standards and norms prescribed by NCAHP.

So, it is hereby informed again that all concerned universities in the state of Uttar Pradesh must constitute a Dedicated Board of studies for Allied and Healthcare education in order to adhere strictly to the guidelines issued by NCAHP with respect to the qualifications of the Dean/ Principal and Teaching staff for allied and Healthcare Education.

Further, all the State Universities / Deemed Universities / Private Universities/ Central Universities conducting courses in Allied and Healthcare Professions are informed to submit a copy of the minutes of BOS meeting (through email to- upsahc@gmail.com) where the matter was discussed on adoption and implementation of the prescribed NCAHP approved curricula mandatorily from the academic year 2026-2027 onwards.
